### PRESIDENT'S UP-DATE

On looking back from the first week of January 2000 to January 1998, I feel bound to express my personal feelings concerning most important matters of endeavour. Myself as President of the NGVR / PNGVR Ex-Members Association and former Colonel of the Regiment (PNGVR) together with your Executive Committee initiated and submitted, with full supporting facts and official service evidence, a number of submissions to relevant Federal Government Departments concerned for service recognition.

Our submissions along with follow up phone calls and faxes etc, have, in some instances been treated with complete ignorance, distain and even aspersions cast on our 24 years of overseas voluntary service in Papua New Guinea under the Australian flag—the only CMF Reserve Unit to so serve in Australian military history. The PNGVR was formed in 1951 in Papua New Guinea and was part of Northern Command, Australian Defence Force. The Unit carried on the magnificent traditions of its parent unit, the New Guinea Volunteer Rifles which was form in Rabaul in 1939.

I speak of the lack of knowledge of PNGVR

on the part of Government Ministers, their Departmental staff and those bureaucratic service personnel who have been appointed to investigate, assess and com-



municate with Associations like ours regarding not only service awards, but prompt courteous and ongoing discussion of service requests on matters peculiar to New Guinea Volunteer Rifles and Papua New Guinea Volunteers Ex Members Association, but so rewarding to the public relations between PNG and Australia.

Only one Division of the cumbersome bureaucracy has given us complete courtesy and a hearing on checking our production of records and service proof. I speak of the Medals Section CARO in Melbourne with its small but dedicated staff.

Since 1990, PNGVR services to PNG have been acknowledged, well recognised and honoured by their (PNG) Honours and

Awards Committee together with several Prime Ministers and Governor-Generals.

Your Committee and myself especially are indebted to Life member Lieut. Colonel Peter Grimshaw, MBE., BA., Dip Acctg., FAIM., FAHRI., JP. visiting Fellow in Pacific History and until recently Business Manager Australian National University, Canberra, for his writings, discussions, phone and fax calls and personal visits to Government in Canberra and constant liaison on every issue myself and your Committee 1. Aug 1998-Submission to Honours & have requested.

Gentlemen, the following is a schedule of occurrences which I have placed before 2. the Association Committee and our Hon. Solicitor Bruce Crawford, and our member Solicitor, Utz Wellner not only for approval 3. but also to be cleared legally of any malice or defamatory wording. Copies of correspondence, letters etc and the meager replies from government are available from 4. the Association's Secretary, Members Representatives or myself.

Fifty-five years ago World War two ended for the NGVR and twenty-six years ago PNGVR was disbanded. However historically, we are very much alive through our Association. Should any member feel he can further our cause by approach to political entities or parties, please contact your Executive Committee.

Our activities to date have been:-

- Awards Office, Canberra re the AASM supported by two personal visits and numerous phone calls—nil result.
- Sept 1998—Submission to Department of Defence also on the AASMno response.
- To January 1999—Numerous phone calls to Canberra re the AASM and definition and eligibility of PNGVR-nil result.
- Aug-1998- Submission to Hon. B Bishop, Minister for Defence & Personnel Canberra seeking the re-



LEST WE FORGET



To July 1999—phone call and faxes finally locating Commander Bloomfield, AM., RAN, Director of Honours and Awards Canberra (but only available in Sydney for person to person contact).

- Written submission sent 21 July re. 10. The AASM. Only an acknowledgement was received three months later on the 15 October 1999. It is worth noting that the Association has phone, mail, fax and Email contact points, and nominated Members who can attend any relevant "discussion" or meeting almost anywhere in Australia., yet government communication is slow, if at all.
- From July to December 1999, three meetings of the Review Board of service entitlements and anomalies in respect of South East Asian service 1955-75 were held with two in Queensland locations by Commander Bloomfield. In spite of our formal submissions and communications we were **not** invited.
- I had three phone conversations with Commander Bloomfield seeking answers on our letters and our nonattendance at review meetings. When pressed for answers he promised to investigate and, if feasible, to set up another meeting either on the Gold Coast or a northern NSW location, so we could attend. Again, nil advice-nil result. When the issue was raised with Canberra, it would appear that they know nothing about us. At one stage, receipt of our AASM submission was actually DENIED, when in fact we had a letter of acknowledgement of receipt of our submission signed over Commander Bloomfield's name. We had to fax this government receipt to Canberra and suddenly our submission was acknowledged. (NB During these events, we were often told by the bureaucrats that they had no knowledge of PNGVR yet we were very much a part of the Australian Defence Force with a unique history.)
- In July 1999, we forwarded a detailed

- submission to Canberra seeking the awarding of the ASM with PNG clasp to former PNG Nationals of the PNGVR, offering to assist in locating former members and to use our records, RO's and personal knowledge to confirm applicants. No response, even though we know our submission was received.
- In November 1999, on the advice from Commander Bloomfield's office and Department of Defence, I phoned the Prime Minister's office in Canberra. Two conversations with two bureaucrats regarding the inclusion of our PNG awards in our Australian service records and the awarding of the ASM with PNG clasp to PNGVR Nationals took place. I could barely restrain my anger at their total lack of knowledge and pompous evasiveness, in short, they told me that seeing we were from New Guinea, we should go and see the PNG High Commissioner to Australia. I have passed on the names of these "public servants" to our two member solicitors.
- During 1999 Lt. Colonel Grimshaw and myself have been communicating almost weekly by phone and fax and have built up a wonderful file of letters and historic information on these subjects which have been tabled at your Committee meetings. Prior to Christmas we agreed that we should, if possible, attend in Canberra the final meeting of the Asian service review board. Chaired by Major-General The Hon. Bob Mohr, RFD., ED., RL. and Rear Admiral P Kennedy, AO., RAN. (Ret), Peter Grimshaw attended the meeting but was not permitted to speak, and has since submitted a detailed report.
- Our solicitor Bruce Crawford was requested by your Committee to assist me in final deliberations on all the matters raised. I have received excellent advice and kept Bruce fully informed of all events. Bruce informed me on 5/1/2000 that Minister Scott, Minister assisting the Minister for Defence, has delayed his final report. Perhaps this was due to the searching questions asked by Major-General

how or somewhere a bureaucrat has and dedicated Committee members. finally noted our submission, Regimental history, and that our Queen's HUSAT SANAP WANTAIM MIPELA and Regimental Colours rest in the SEMPER SUMMUS IN EXCRITUS TANTUM Australian War Memorial in Canberra. VARIAT PROFUNDUM. Not forgetting that we all vote.

13. At our Committee meeting 16/1/2000 Bruce Crawford tabled a final letter to Government suggesting that to overlook our submissions will give us grounds to appeal and seek other political assistance.

# HISTORY OF THE N.G.V.R.

Members will be interested to learn that extracts of an N.G.V.R. WAR DIARY were recently found in the Australian archives. They will be re-produced exactly as they were written in future newsletters. Ed.

### N.G.V.R. WAR DAIRY -PART 2

22/1/42 Suggested to 8 M.D. that full mobilisation of NGVR including government officials be made immediately. 8 M.D. requested details of petrol and oil stocks still remaining Madang, Salamaua, Lae. Approval granted 8 M.D. for expenditure pounds 300 for construction operation HQ and store depots.

23./1/42 Instructions from 8 M.D. to advise Salamaua to clear aerodrome immediately—8 M.D. unable to make radio contact. 8 M.D. advised later that day that RAAF now in touch with Salamaua, 'drome had been temporarily cleared, and no action by NGVR HQ was necessary. The fox moth left for Port Moresby 0600 hours. Total strength all areas NGVR and attached personnel at date 12 Officers and 327 OR's—total strength 339. Instructions from 8 M.D. to mobilise NGVR immediately. Salamaua advised. Madang advised. 8 M.D. advised all W/T communication with coast was dead—no details. Madang instructed to collect two W/T sets in custody of D.O. and forward to Bulolo immediately by air. Radio to 8 M.D."The Aerodrome" is OK. Instructions passed on to Lae, Salamaua and Madang Branches Bank NSW to destroy, in extreme emergency, notes, war savings certificates, travelers cheques in presence of suitable witnesses. No. 2 Platog (Bulaw) under Sgt Jocumsen instructed to proceed to Lae area and join the Lae detachment in Lae itself if still in occupation by our troops, or to assist in fighting a rear-guard action if necessary. General instructions to hold a line Gabensis/Wampit, and to keep enemy from getting in last foothills. If enemy remain in Markham

Valley, harassing tactics to be adopted.

24/1/42 Requested by Sigs. 8 M.D. to commence immediately a listening watch on 4775. Advised by Madang that after air attack (bombing and MG fire) civilians have left Madang and are now in the vicinity of Amele en route to Ramu. NGVR still in contact in Madang. Instructions requested. Advised 8 M.D. have taken over stocks of B.P's Bulolo Branch and B.G.D. in view of uncertainty of supply position. Admin taking over all supplies in Wau area. 8 M.D. requested to forward supply of flour immediately. Above action confirmed by 8 M.D. radio and advised flour and ammo being sent by RAAF plane first opportunity. Administrator left for Port Moresby per Moth aircraft (24th or 25th). Advised 8 M.D. petrol stocks at Lae and Salamana as Lae 300,00 gallons and Salamana 250,000 gallons. Oil stocks unknown. Advised 8 M.D. plane required immediately to collect radio transmitters ex Madang and place on watching stations. Only plane is district is required by Admin. Requested permission from 8 M.D. to recruit Chinese and malays for transport and medical duties.

25/1/42 8 M.D. advised no news had been received from force (NGVR & 2/22nd) at Rabaul since early 23/1/42, and enquired whether possible to send patrols from this district to contact and report. Madang Det. Instructed to remain in Madang to report daily. On sign of occupation to destroy what could not be removed. Civilians to carry on to Ramu. NGVR withdrawn outside limits of Wau town area..Legal officer 8 M.D. requested to advise whether NGVR had power to override Administration. Legal officer suggested NGVR assume all necessary authority.
