I write as the Chair of the Executive Committee.



These are: James Keenan, Bruce Fraser, Fred Still; Jim Cavanaugh and Harry McCauley from NGVR and Jim Lewis, Michael Konecny, Peter Harbeck, Bill Kelly, Alan Booth and our inaugural and long serving President Harry Green and Joe Fisk from PNGVR.

The Executive Committee of the Association has decided all positions of the committee will be elected by a independently supervised postal ballot with the results available at our AGM and reunion. The date of the AGM will be August/September depending on when the Sergeants Mess at Enoggera is available to us.

The Association is strong financially and functionally. The current Committee comprises hard working and dedicated men, as the quality of recent events and activities attest. Additionally, our main activities programme for the year has been completed. The wonderful historic display at our Post-march reunion, which included the "handkerchief" from the Montevideo Maru passenger was presented by John Holland.

Lt. Colonel Harry Neville Green, MBE.ED 30 October 1921 - 9 April 2005.

On the 22 April 2005, just three days short of ANZAC Day, over 120 Association members, family members and guests attended the Memorial Service for our Late President, Lt. Colonel Harry Neville Green, MBE.ED. The moving Service was held at the *All Saints* Chapel at Gallipoli Barracks in Brisbane.

Harry passed away in Cairns on the 9 April after a long and hard fought battle with cancer. Following a Funeral Service in North Queensland, Harry's ashes were bought back to Brisbane where his beloved daughter Nicky, and members of the Executive hosted a Memorial Service.



Obituary for Lieutenant Colonel Harold Neville Green, M.B.E (Mil), E.D 1921-2005

The death of Lieutenant Colonel Harry Green on 9 April 2005 heralded the end of a colourful and fruitful life and the passing of one of the last of the great Pacific Islands traders. Harry a man of vitality and charm had an unquenchable thirst of life. He was an inveterate networker, initiator and doer. The military played a large part in his existence, not just on the parade-ground but in his other activities as entrepreneur, businessman, planter, boat builder, trader, aviation owner, husband and father.

Harold Neville Green was born on 30 October, 1921 in the New South Wales town of Mullumbimby near Byron Bay. Harry's father was a bank manager who was transferred regularly around the State. During the depression Harry lived with his father at Canowindra, west of Orange, while his mother lived with his sisters in Sydney. In 1936, his father and Harry returned to Sydney where Harry attended secondary school.

He began 40 years of voluntary military service when he enlisted in the 17th Infantry Battalion, North Sydney at the age of 15 years. He enlisted in the AIF on 13 May 1940 at 18 years of age and served with the 2/1 and 2/4 Light Anti-aircraft Artillery Regiments. After a years training at Ingleburn, NSW, the Regiments served in the Middle East including Syria, Egypt and Palestine. returning to Australia prior to the battle of El Alamein in 1942. After undergoing further training on the Atherton Tablelands, the unit saw action at Lae and Finschhaven. Returning to the Tablelands late 1943, Harry served out his time until his discharge, as a Corporal on 7 November 1945, having served 2005 days including 704 days outside Australia.

After further schooling and a stint at University, Harry was employed by Vesteys, and from 1947 travelled regularly to Port Moresby, Lae, Madang and Rabaul for the company. In 1950, Harry reenlisted in the CMF with the 17th Light Anti-aircraft Regiment at Middle Head, Sydney as a gunner. He was promoted sergeant in 1951, then WO2, and was commissioned as a Lieutenant on 26 February 1952. Harry lost his right arm near his shoulder in a motor accident in Sydney in 1952. He never wore a prosthetic arm.



In 1954, Harry accepted Gillespie's offered company directorship in Papua New Guinea and moved with his family to Rabaul. Harry's military status at this time was Captain, unattached to PNGVR. He took up his PNGVR, B Company Commanders position in 1958 after completing his DA 21A majority course at Canungra in 1957.

He left Gillespie to work with Alex Hopper and Co in 1958, where he learnt about trading skins, shell and other tropical produce. In 1959, he left and set up Green and Company Limited in Rabaul, exporting cocoa beans, various shells and crocodile skins. He became a consummate trader. Harry also went into plantations and was involved with, either as an owner or a director, Bali (Witu Islands), Londolovit (New Ireland), Iwi (Bougainville), Marau and Kolai (south coast of New Britain) and Paluat (Gazelle Penninsular) plantations.



Another successful venture was Plantation Charters. Harry arranged recruitment of labour from the PNG Highlands through his friend Denis Buchanan. Denis set up Talair, for this purpose, recruited and equipped the labourers, and with Harry's three DC3 aircraft flew them direct to New Guinea Island plantations. Instead of waiting 6 months to get a line of labour, they arrived within weeks.

Harry was active in the community. Civic roles included Boy Scout Commissioner for 15 years; Chairman, NG Islands, Winston Churchill Trust for six years; Executive Member, Papua New Guinea Planters Association for 16 years; President, PNG Native Ex-servicemens Association for 16 years; Chairman, Anglican Plantation Trust for New Ireland and New Britain for six years; Trustee for New Guinea Islands RSL for ten years; Executive Director, Bougainville Trading and Shipping Company for eight years and Director, BRW Plantations Limited for 16 years.

In 1965, Green & Co established operations in Bougainville and on Munda Island and at Honiara in the Solomon Islands. He brought his boats from Kieta and started a shipyard at Honiara. He set up a trading company at Kieta Bougainville and was involved in the sale of Kip McKillop's plantation Arawa to Bougainville Copper, after which he was appointed the company's purchasing agent, a major coup.

Financial problems arose in 1970 when his company sold forward a large shipment of cocoa beans just prior to a massive price rise. Under the contract, the purchaser could call forward exported balances and if the seller could not supply, the buyer could buy in the market and debit the variation of cost to the sellers account. Sufficient supply could not be bought and Green & Co eventually went into liquidation in 1972. Harry managed to retain his home in Rabaul, Paluat Plantation and his boats. Paluat was later compulsorily acquired by the Government.

The early 1970s saw Denis Buchanan, with Harry's assistance purchase the Solomon Islands' Airline and Vanuatu's Air Melanesia. Unable to buy Fiji's Air Pacific, they became agents for Air Nauru and Air Pacific and purchased an aircraft which flew daily between Rabaul, Kieta, Honiara and Port Vila, right through to 1980.

Harry married twice. His first marriage was to Patricia Jean Brittain in Sydney in September 1940. They had three children, Penelope Carol, Nicola Jane and Roger Brittain, all born in Sydney. The Greens returned to Australia in early 1970's when Harry bought a hotel at Theebine and a cattle run on the north coast. While these provided an Australian base for the family, the lure of the Islands proved too strong. Patricia and Harry divorced in 1980. Patricia died in 1991 in Gympie. The three surviving children live in north Queensland, Brisbane and Sydney respectively.

After PNG attained its Independence in 1975, Harry took stock of his situation and moved to Honiara in the late 1970's. He married Margaret Louise McIntosh in 1983. They had no children. They lived in Honiara and Port Vila spending two weeks at a time in each. Harry ran a successful insurance office in each town for Cigna, Insurance of USA. When there offices were closed in 1986/7, they decided to live in Brisbane. However, Harry's PNG Island activities kept him travelling backwards and forwards. Harry brought his son Joshua Luke, who was born at Paluat Plantation in 1993, to Australia in 1995 to be treated for virulent malaria. Margaret and Harry divorced in 1999. Joshua lives in north Queensland.

In the later half of 1958, Major Harry Green became the Company Commander of B Company, PNGVR in Rabaul. This was the start of his 16 years association with the Regiment. PNGVR and its WW2 counterpart, NGVR were the only volunteer Citizen Military Force units which were formed, served and disbanded overseas. They were also in the Australian Army Order of Battle, that is, they were front line units.





Harry became 2i/c of the Battalion in 1963. Upon reaching the mandatory age of 47 years in October 1968, he retired from PNGVR with the rank of Lieutenant Colonel. In 1970 he was appointed Honorary Colonel of PNGVR, the fifth and last of those who served in this prestigious position, until PNGVR's disbandment on 1st December 1973.

Highlights of his PNGVR activities were assisting the Administration during the trouble in the Gazelle Peninsula which boiled over due to the alienation of so much arable land from the local people for plantations. This had been occurring since early German times. Arguably the greatest achievement of PNGVR was its integration as a multi racial unit in 1964. The idea of integration came from PNG, particularly officers like Harry, who in defiance of regular directives of discouragement from Canberra, made it happen. Harry Green as 2i/c of the Regiment, with the support of the company commanders and good will of all participants made it work.

The culmination of the units many achievements was the presentation of the Queen's and Regimental Colours by the Administrator at PNGVR's 1969 annual camp at Igam Barracks, Lae. PNGVR was a great CMF unit. Indeed, there is an aptness in the unit's motto "Per Angusta Ad Augusta" - Through Trials to Triumph.

Harry was part of PNGVR for 16 years, from the time of small weekly parades of Europeans and through its growth into a multi racial force to its disbandment and laying up of its Colours on 25 April 1974 in Canberra. Harry's leadership, flair, experience and knowledge assured PNGVR's high standing and regard were maintained.

Harry was President of the NGVR and PNGVR Ex-members Association for 16 years from its official start in 1989 until his death. The Association was alive and vital from its outset. Under Harry's leadership, the Association was arguably the best "turned out" in Brisbane Anzac Day march. Harry was the easily recognised, white haired, moustached, one armed, much medalled, florid faced man of soldierly bearing marching proudly in front of his men. Harry's long and inspired leadership allowed the Association to achieve so much.

In recognition of his many years of voluntary military and civilian service in Australia and New Guinea, Lieutenant Colonel Harry Green MBE (Mil), E.D received many awards and decorations. Little known to most, Harry was also an avid reader and lover of classical music and animals. Earlier pursuits were snorkelling and collecting shells.

Harry died on 9 April 2005, aged 83 at Gordonvale Memorial Hospital. His funeral and cremation was held on 13 April 2005 in Malanda and a memorial service was arranged at the All Saints Chapel, Enoggera Barracks, Brisbane by the Association on 22 April 2005.

Papua New Guinea and the Pacific Islands have lost a friend who helped develop their potential from his first visit in the 1940's, until his death. Australia has lost a man who was outstanding in his many and varied achievements.

I DO NOT KNOW OF ANY OTHER PERSON IN PNGVR WHO SERVED IN MORE LOCATIONS THAN JOE - MADANG, RABAUL, PORT MORESBY, MT HAGEN AND WEWAK. JOE SERVED WITH EVERY COMPANY IN PNGVR EXCEPT, A COY, LOW, AND SUPPORT COY, PORT MORESBY.

AFTER VAL AND JOE MOVED TO BRISBANE IN 1973 HE MET NORM MUNDY, A FRIEND FROM PORT MORESBY, AND WAS OFFERED A POSITION AS AN INSTRUCTOR WITHI TRAINING GROUP, WACOL, IN 1976 - HE RETIRED FROM THERE IN 1985 AND WAS AWARDED THE HONORARY RANK OF WOI THIS IN ITSELF WAS QUITE UNIQUE AS, IN THOSE DAYS, SOLDIERS OF THE RANK OF MAJOR AND BELOW HAD TO RETIRE AT AGE 47. IT IS A TESTIMONY TO JOE'S KNOWLEDGE AND ABILITY TO RELATE TO PEOPLE THAT HE WAS KEPT ON UNTIL AGE 55 - BUT THAT WAS JOE - AN EXCELLENT INSTRUCTOR WHO RELATED WELL TO SOLDIERS.

SOME WORDS NOW ABOUT THE NGVR/PNGVR EX MEMBERS ASSOCIATION.

I HAVE ALREADY MENTIONED THAT JOE AND NORM MET IN BRISBANE AFTER THEY MOVED SOUTH - BOTH LIVED AT DAISY HILL. BOTH HAD SHOWN THE FORESIGHT TO GET NAMES AND ADDRESSES OF EX MEMBERS OF PNGVR BEFORE THEY LEFT NEW GUINEA AND IN 1981 THEY, TOGETHER WITH THE ASSISTANCE OF PETER ROGERS, WHO WAS STILL SERVING, COMMENCED TO HOLD MEETINGS OF EX MEMBERS OF PNGVR, AND THAT WAS THE COMMENCEMENT OF THE STRONG ASSOCIATION THAT EXISTS TODAY. JOE SERVED ON THE COMMITTEE IN A VARIETY OF POSITIONS BUT, OF RECENT TIMES, VERY APPROPRIATELY AS 'MEMBERS REPRESENTATIVE' UNTIL LAST YEAR.

JOE DISPLAYED A THOUGHTFULNESS AFTER THE ASSOCIATION WAS FORMED THAT I HAD NEVER QUITE SEEN IN THE EARLIER DAYS. SOME OF HIS ACHIEVEMENTS SINCE THE ASSOCIATION WAS FOUNDED ARE:

- i) THE DESIGN AND PRODUCTION OF A POCKET BADGE, TEE SHIRT, TIES AND CAPS
- ii) DESIGN AND PRODUCTION OF UNIT PLAQUES, CAR BADGES AND LAPEL BADGES.
- iii) DESIGN AND PRODUCTION OF THE HONOUR BOARD (I CAN STILL HEAR HIM SAYING A COUPLE OF WEEKS AGO -"I KNEW MY NAME WOULD BE ON IT BUT DIDN'T EXPECT IT TO BE SO SOON"
- iv) DESIGN OF 2 PLAQUES FOR THE HALL OF MEMORIES IN ANZAC SQUARE NGVR AND 'MONTEVIDEO MARU' PLAQUES.
- v) DESIGN AND FORMAT OF FUNERAL PROCEDURES FOR MEMBERS (TOGETHER

EULOGY GIVEN BY BOB COLLINS 6TH MAY 2005

JOSEPH HENRY FISK

I FIRST MET JOE IN MADANG, NEW GUINEA, IN 1959. WE BOTH WENT TO NEW GUINEA IN 1959 AND WE SERVED IN THE PNGVR TOGETHER, WE PLAYED RUGBY LEAGUE TOGETHER AND WE KNOCKED ABOUT TOGETHER

A WORD FIRST ABOUT JOE AND HIS RUGBY LEAGUE. JOE LOVED HIS FOOTBALL AND PLAYED IT THE SAME WAY HE LED HIS LIFE IN THOSE DAYS - SIMPLE AND UNCOMPLICATED. HIS ATTITUDE WAS - IF HE HAD THE BALL AND YOU GOT IN HIS WAY - HE JUST RAN RIGHT OVER YOU. IF YOU HAD THE BALL AND JOE WAS ANYWHERE WITHIN REACH HE HIT YOU AS HARD AS HE COULD - HARD BUT FAIR (MOST OF THE TIME ANYWAY).

WE PLAYED TOGETHER IN 1959 AND 1960 THEN JOE WAS TRANSFERRED TO RABAUL WHERE HE CONTINUED PLAYING ARMY AND WARATAHS. HE THEN CONTINUED PLAYING WHEN HE WENT TO PORT MORESBY WHERE HE PLAYED WITH MAGANIS.

IN THOSE DAYS WE HAD WHAT COULD NOW BE DESCRIBED AS A STATE OF ORIGIN - PAPUA Vs NEW GUINEA - PLAYED TWICE ANNUALLY AND THE GAMES, LIKE STATE OF ORIGIN TODAY, WERE HARD AND TOUGH. JOE HAD THE UNIQUE DISTINCTION OF REPRESENTING BOTH PAPUA AND NEW GUINEA AND HE GAVE OF HIS BEST NO MATTER WHO HE WAS REPRESENTING.

AFTER HE WAS MARRIED IN MT HAGEN HE GAVE UP PLAYING RUGBY LEAGUE, BUT TOOK UP THE WHISTLE AND BECAME A REFEREE - HE REFFED IN BOTH MT HAGEN AND WEWAK. JOE WOULD HAVE BEEN A GOOD REF AS HE HAD PLAYED AT THE HIGHEST LEVEL IN NEW GUINEA. IT DOESN'T TAKE MUCH IMAGINATION TO VISUALISE A PLAYER SAYING TO JOE " DIDN'T YOU SEE HIM HIT ME SIR?" JOE'S REPLY WOULD HAVE BEEN "OF COURSE! BUT HE WAS ONLY GETTING SQUARE FOR WHAT YOU DH) 5 MINUTES AGO. SHUT UP AND GET ON WITH THE GAME". THAT'S HOW GOOD REFS DID IT IN THOSE DAYS.

I WOULD NOW LIKE TO SPEAK ABOUT HIS MILITARY SERVICE . JOE COMMENCED HIS MILITARY SERVICE WHEN HE WAS CALLED UP FOR NATIONAL SERVICE WHICH HE COMPLETED AT INGLEBURN, SYDNEY.

SERVICE LIFE OBVIOUSLY SUITED HIM AND HE CONTINUED TO FULFIL HIS NATIONAL SERVICE OBLIGATION IN THE 45^{TH} BATTALION, THE ST GEORGE REGIMENT, NOW THE $4/3^{RD}$ BATTALION, ROYAL NSW REGIMENT. DURING HIS SERVICE WITH THE 45' BN HE ROSE TO THE RANK OF SGT.

WHEN HE WENT TO MADANG, NEW GUINEA, HE TRANSFERRED TO THE PAPUA NEW GUINEA VOLUNTEER RIFLES AND, WHEN I MET HIM IN 1959, HE WAS THE PLATOON SERGEANT, 7PL COY. IT WAS IN MADANG THAT I FIRST JOINED THE CMF AND I FEEL VERY PRIVILEGED TO HAVE HAD JOE AS MY PLATOON SGT.

JOE WAS A GOOD PL SGT. HE HAD THE SAME ATTITUDE TO THE MILITARY THAT HE HAD TO EVERYTHING ELSE - KEEP IT SIMPLE AND UNCOMPLICATED. HE WAS EVERYTHING A PL SGT SHOULD BE - KNOWLEDGEABLE, HELPFUL, ABLE TO COMMUNICATE WELL, AND, MOST IMPORTANTLY, ABLE TO UNDERSTAND AND GET ON WITH PEOPLE IN ALL WALKS OF LIFE. JOE TRANSFERRED TO PNGVR, RABAUL, AFTER MADANG. HE BECAME THE CSM OF B COY, WHILE STILL A SGT. KEN MACGOWAN REFERRED TO JOE ON THE PHONE YESTERDAY AS THE BEST CSM
