Good evening Mr. Dining President. our Patron, ladies and gentlemen,

The AGM at the Long Tan Sergeants Mess was a little over a month ago so I have little to say. The next few months is our quieter activities period in our yearly cycle. None the less, we will not be going to sleep.

Our speaker at the AGM, Bruce Petty from New Zealand has been in touch and is seeking information about the CHAMORROS family who originally came for Guam during German times either to L.ae or Rabaul. They eventually moved to Australia and one part of the family currently resides in Brisbane. Unfortunately the older generations of the family did not speak of their PNG background . particularly place names and dates, and the children are wondering about their past, and a friend of Bruce's is using the family as a theme for a TV event. The Chamorros may have been involved in German missionary work or with Queen Emma's or others in their south sea trading enterprises at that time Many one can assist, pleases see me after the dinner.

On the 6th October Colin, Bruce and I attended a meeting with Colin Bell and his NSAAQ Committee at Wacol to discuss our lease. 
Oualified Audit Opinion

I present to you the Financial Report for the year ended 30th June, 2007 together with an independent Audit Report from Sciacca & Co, Chartered Accountants.

We are indeed blessed with a net profit of \$3,599.84 for the year after carrying out the various functions through the year such as Montevideo Maru Memorial Service, AGM, ANZAC Day, Regimental Dinner and the twin plaque dedication ceremony at the Australian War Memorial in Canberra.

As compared to last year the bulk of the income for the year comes from:

Our Secretary, Colin Gould, who is also the Chief Editor of Harim Tok Tok, managed to send out at least 4 or 5 editions for the year.

This important printing communication exercise, which is envied by other military organizations, comes at a cost of just over \$10 per member per year.

At the end of the financial year we have \$8,427.87 in the Bank Account and \$15,000 in Term Deposits making a total of \$23,427.87 in the Bank and no bills to pay!
